Associate of Arts/Oregon Transfer (AAOT) Degree & Associate of Science/Oregon Transfer Degree in Business (ASOTB)
 – The courses listed above may be included in the AAOT and ASOTB degree. Students who complete this degree and are accepted at Oregon public universities will be admitted as having completed all lower division comprehensive and General Education requirements for a baccalaureate degree.

Associate of Science (AS) Degree – The courses listed above may be included in the AS degree. The degree does NOT guarantee that students will be accepted as having completed all lower division comprehensive and General Education requirements for a baccalaureate degree. Student should work with an Academic Advisor to plan for transfer to the school and major of their choice.

Transfer without a PCC Degree – Students may elect to earn credits and transfer to a four-year institution without earning a PCC degree. Please meet with an Academic Advisor for an individualized plan of study.

Majoring in Business

Pre-Business Major

Undergraduate students who want to enter the business program spend their first two years as pre-business majors. During this time students will complete both pre-business requirements and university general education requirements.

Major in Business Administration or Accounting

Once students have completed the [pre-business requirements](#) they may [apply for admission](#) to the major. Students may choose to major in either accounting or business administration. A cumulative GPA of 2.90 and a minimum of 90 credits are required for application.

The **Accounting** curriculum is designed for students who want to embark on a career with a strong accounting emphasis.

The **Business Administration** major offers career oriented concentrations in a diverse range of study areas.

Get a Concentration

Business administration majors may select a concentration in a particular area of study. Choose from the following set of concentrations: [Finance](#), [Marketing](#), [Sports Business](#), [Entrepreneurship / Small Business](#), [Information Systems & Operations Management](#).

Major Program Application

To register in upper division business courses you must first apply and be admitted into the major. Applications are due by the second Friday of the term one term prior to registering for upper division courses. (You can be enrolled in your final pre-business requirements at the time you submit your application.)

Once your request has been submitted we will review your student record to ensure that you meet all the [admission requirements](#) for the undergraduate major in business. You will be notified via mail of our decision. If you are currently enrolled in [Pre-Business Core](#) courses, or if your cumulative G.P.A. is currently below a 2.75, we will process your application after grades are posted at the end of the term.

Additional requirements for pre-business majors:

Pre-business students are required to submit a written plan, for departmental approval, to the Undergraduate Programs Office, 145 Lillis, outlining how you will meet the following two requirements. Proposals may be turned in at any time, however, you are strongly advised to turn one in for approval prior to taking these courses and your plan must be on file in 145 Lillis before graduating.

Non-Business Breadth Requirement:

24 credits from an inter-related set of courses, outside of business, that relate to your career interests. Completion of a minor will automatically fulfill this requirement, as will two years of college-level foreign language.

Global Context for Business Decisions:

Three courses that focus on the culture of a country other than your native country. All three courses should focus on the same country or region. Courses must be at least three credits each. Foreign language courses must be at least 200-level or higher.
