Please allow at least 10 business days for document evaluation and residency verification.

NOTE: To be eligible for residency reassessment, this form is due in any Admissions and Registration office NO LATER than the drop deadline of the term for which you wish to have your tuition reassessed. Residency updates are NOT retroactive and cannot be applied to a previous term.
