- ATD
 - Thanks to Patti and Mona for coordinating 39 people to get to the conference
 - Seeing the authenticity of how everyone is committed was validating, great momentum
 - EAC proposal was approved, equitable representation, they will rewrite their bi-laws to reflect the membership change and how it will impact other departments
- New Rules for Accreditation
 - NWCCU federal regulations will take effect July 1, essentially all regional creditors can become national creditors. The new regulations will eliminate the historical restriction that regional accrediting agencies can accredit only colleges and universities located in their geographic regions
- Elected to ACE Board - support DACA rescission. ACTION: Ryan/Chris - set up a call with Terry about perspective opinions should one opinion dominate
- Cascade Basketball team will travel to Everett WA via a waiver form understanding the risk, Mt. Hood, Clackamas and Lane are sending teams as well. (Event was canceled on Thursday March 5th)
- Legislative Update:
 - Republicans have left town, both in the house and the senate - bills are languishing
 - OCCA supportive of incorporating into the next budget request investments for benefits integration bandwidth

- OPC funded a trial of pilot of four community colleges to receive funding for benefits integrators on four different campuses, then collect the data to support a broader request in the next long session
- One finalist for the Government Relations officer; Emma willing to extend her stay
- PCEF tax is being implemented, 25% will go toward Workforce Development, goal is for a greener economy for Portland, PCC involvement to be determined, bound by territory. Projected revenue is \$73M, 25% of that available for Workforce Development
- Kresge Foundation awarded a \$495,000 grant to PCC and Albina Head Start to connect low-income students to human services and educational pathways
- Pathways to Opportunity has been selected by the National Skills Coalition to take part in its SkillSPAN and the Supportive Services Academy
- Updates:
 - Tammy: Determined a separation date for our financial aid processing with Oregon Coast, mid-May
 - Eric: New Executive Assistant starting on Monday, March 9th.

- Reorganization/Change Management - Sylvia & Mark
 - Working on communication plan Discussing timeline today, and activities that need to happen within that timeline, decide when design teams will be put together

New program/viability process**

- Two groups formed, one will examine proposal process, aiming for a clear calendar for submission and processes, simplify, encourage ideas
- Strategies for advancing equitable student success and faculty hiring
- The new programs will lead to economic mobility and help create better pathways for students of color
- Open or closed program licensing requirement, shorten timeline, modify program or new program
- More pre-planning and thought, anticipated enrollment and cost, strategy to keep program moving forward, and decide on delivery mechanisms
- Automation process being discussed, link to the topic of sustainability
- Reorganization will have an impact as well
- Most evaluation happening between Phase I & II before it reaches Cabinet
- Ultimately Cabinet will approve all programs, then submitted to HECC

General Ed and Institutional Learning Outcomes Work/Decisions

- Conversations and feedback going on around the college, stemmed from Gen Ed redesign. Come up with a signature assignment and shared outcomes, then accreditation changed
- Three outcomes:
 - Gen Ed outcomes and assessment resides entirely in Gen Ed
 - Gen Ed outcomes become our institutional student learning outcomes (ISLOs)/core competencies
 - Additional ISLAs/Core Competencies are adopted; Gen Ed Outcome become a subset of our ISLOs/Core Competencies, add, for example (Communication), Teamwork, Problem Solving, Creative thinking etc.
- Joint faculty leadership team gathering feedback to make a recommendation to Cabinet for a decision about direction and process

11:25 am **Coronavirus (COVID 19) Update - Eric Blumenthal**

- Coronavirus [Centers for Disease Control and Prevention \(CDC\)](https://www.cdc.gov/coronavirus/)
- Coronavirus Task Force has been formed to funnel the intelligence we are receiving, they are tasked with deciding responses and design phases of action:
 - Phase I - not a direct PCC faculty, staff or student
 - Phase II - Direct member of PCC
 - Phase III - More than one person being affected
- Working with Federal, State and County agencies
- Cases most of concern, persons under monitoring (PUM) contact with someone who has the virus or contact with countries infected at Level II
- Persons Under Investigation (PUI's)
- Lack of Corona Virus testing kits
- Faculty, staff and students returning from infected countries will follow protocol entering back into the states.
- Human Resources is getting a lot of questions, must be 24 hours free of symptoms without medication to come back to work
- Communications went out on Monday, will have a series of messages that will come out more frequently
- Confirming cleaning procedures to keep facilities safe
- **ACTION:** Form a small policy group to sort through policy and formulate a plan early for continuity with emergency response and Human Resources for answering staff questions. Lisa & Eric will put this group together
