Guided Pathways: Eriks Puris

DISCUSSION ITEMS:

Small Certificates

- Small certificate programs, like 17 credit **ACERTP-LATE: Landscape Technology Entry Level Less Than One-Year Career Pathway Certificate**, are not required to report program assessment results. **HOWEVER**, they are still strongly encouraged to conduct program assessment to determine whether students are in fact meeting the certificate outcomes. One way to insure this is to better align small certificate outcomes with those of the larger certificates and degrees that are required to report assessment results.

Cultural Literacy

- A goal of Gen Ed reform at PCC was to ensure that all students are instructed and assessed in PCC's Core Outcomes. Currently, the Gen Ed requirements for the AGS, AS, and AAS degrees do not include a course with a Cultural Literacy designation. How do we ensure that AGS, AS, and AAS graduates are instructed and assessed in the Gen Ed Cultural Literacy outcome?

 - The DAC will inform the EAC that the committee is now beginning to consider these issues.
 - The original Cultural Literacy outcome has been suspended and is under review once more. On 2 occasions SAC signature assignments received a score of "0" according to the rubric.
 - Faculty from all Gen Ed courses with a CL designation have convened to begin the process of reviewing and revising the CL outcome.
 - The DAC will not make a recommendation at this time, since the committee does not yet know what the outcome will be.
 - There are two dimensions to this discussion: a philosophical one and a mechanics one. We need clarity and intention on both dimensions.
 - CL is central to [PCC's mission](#), but for academic year 2018-2019 only approximately 550 AAOT students were required to take a Gen Ed course with a CL designation (compared to over 3000 AGS, AS, and AAS students who were not required to take a Gen Ed course with a CL designation). Are we following the college's stated mission?
 - What would a CL assessment look like for CTE? Should CTE programs develop their own program-specific rubric for assessing and scoring for CL in a way that could relate to CL as an institutional outcome?

Degree Outcomes

- Are the new Gen Ed Outcomes sufficient for institutional learning outcomes and degree outcomes? Will the assessment of the institutional outcomes in the Gen Ed course be sufficient or will the CTE programs have additional

assessment responsibilities? A table with a variety of answers to the answer was briefly examined.
