#### **Membership**

- Currently the Curriculum Committee and the Degrees and Certificates Committee have different voting memberships. The EAC bylaws stipulate for the Curriculum Committee "The voting membership is comprised entirely of faculty." but are mute in regards to the voting membership of the Degrees and Certificates committee. Current practice on the Degrees and Certificates committee is to include advisors and administrators in the voting membership.
- Historically the student member position on the Degrees and Certificates committee has been vacant. We have been fortunate to have a student member the last two years. Initially the student member was assigned an non-voting roll, with little discussion. Would there be advantages to having the student representative be a voting member?
