G303 – Granting Degrees and Certificates

- The policy issue under discussion is whether or not to keep the 1 credit minimum per term to maintain continuous enrollment and guarantee of catalog rights.
- Nikki Patterson in the Registrar's office drafted 5 proposals:
 - i. Retain the 1 credit per term minimum but add language that better clarifies what catalog rights are
 - ii. Remove the 1 credit per term minimum
 - iii. Add language that more clearly defines CTE programs and specific state licensure standards and how that may or may not impact student catalog rights
 - iv. Retain the 1 credit per term minimum but add language that better clarifies what catalog rights are and CTE program definitions
 - v. Remove the 1 credit per term minimum but add language that better clarifies what catalog rights are and CTE program definitions
- The committee will review the proposals and reconvene at the next meeting to discuss them.
