AAS-CJA: Criminal Justice AAS Degree

• This change in line with the changes made over the last three years to better align our degree and certificates with Justice Studies and also to make sure the degree is addressing the knowledge, skills and abilities necessary to work in the contemporary Criminal Justice field.

AAS-FP: Fire Protection Technology AAS Degree

 Reduced total credits from 98 to 90 by consolidating redundant curriculum to help student save money and time.

ACERTP-GREN: Gerontology Professional Less Than One-Year Career Pathway Certificate

• This certificate will be deactivated and is already replaced ACERTP-GRP.

AAS-ID: Interior Design AAS Degree

• Removed ART 116 from the degree and added it to the elective list.

ACERT-IDK: Kitchen and Bath Less Than One-Year Certificate

Removed ID 280A to give students more flexibility and choice towards completion.

AAS-AUT: Automated Manufacturing Technology AAS Degree

• MTH 58/63/65, or a MTH course for which 58/63/65 is a pre-requisite, is now a degree requirement.

AAS-MT: Microelectronics Technology AAS Degree

• Removed MT 111 and MT 112 and added MT 111A and MT 112A.

• This makes the course content more accessible to students and amendable to dual credit.

AAS-SOL: Solar Voltaic Manufacturing Technology AAS Degree

- MT 111, 112 and 113 were split into multiple courses.
- Total credits reduced from 92 to 90.

ACERTP-SV: Solar Voltaic Manufacturing Technology: Career Pathway Certificate

• Merged some concepts from mechatronics.

AAS-OMT: Ophthalmic Medical Technology AAS Degree

• Consolidated 5 practicum courses into 4 courses.

PREREQ-OMT01: Ophthalmic Medical Technology Academic Prerequisites and Requirements

• Changed MP 135 into an academic prerequisite.

AAS-PARA: Paralegal AAS Degree

• Added 2 new elective lists to give student more flexibility towards satisfying the BA and WR requirements.
