STANDPOL-G307: General Education Outcomes

- Committee recommends for approval the changes to the old Cultural Literacy, now Social Justice, outcome.
- Currently, these general education outcomes are not officially the college core outcomes or ISLOs (Institutional Student Learning Outcomes). Work has begun again on the question of what PCC's ISLOs should be.
- Reminder: Social Justice is an *extra* or *additional* designation for a general education course. For example, ENG 104 is an Arts & Letters / Integrative Learning gen ed course but does not meet the Social Justice outcome requirements due to its CCOG. ENG 244 is an Arts & Letters / Integrative Learning gen ed course *and* meets the Social Justice outcome requirements. Both are Arts & Letters / Integrative Learning but only one gets the extra course designation because of its CCOG.
- The Social Justice outcome will continue to map to the state's AAOT cultural literacy degree requirements.
- The current college core outcomes are at least 30 years old, and they were at that time not tied in any way to institutional assessment. They were simply a statement of the college's educational values. Since then, however, the accreditation landscape has changed, and institutions are now required to demonstrate how core outcomes are being assessed.
- The Social Justice DSAC decided the term "cultural literacy" was outdated, inappropriate for the contemporary context, and needed to better reflect what was being taught in courses.
- Over 3 years of work went into crafting the outcome language and the assessment rubric. The rubric is ready to be piloted with course assignments, which will require much more faculty labor.

• More needed faculty labor on mapping assignments to the Social Justice assessment rubric needs to be intentionally addressed by the college.
