Degree Mapping – Jen Piper and Anthony Hunt

Jean Flores, Anthony Hunt, and Jen Piper are co-chairs of this project that started in fall 2024. There are three phases, and we are entering phase two. Phase one focused on creating one to three program maps in each pathway during fall 2024, with pathway teams helping throughout this process. Program maps will be created for all CTE degrees and certificates (AAS and certificates that are between one to two years). We are also mapping all LDC areas to the AGS and the CTM.

PCC currently has 174 degrees and certificates, with 122 listed courses and 52 sequenced courses. 19 maps have been completed so far, and the goal is to have all maps completed by fall 2026. Phase three will examine how these degree maps can be integrated into the advising system, but is not meant to replace advising since students have different needs and goals. These degree maps will eventually be put on the PCC website and will be student-facing.

Key phrases:

- Pathway teams Made up of staff from academic affairs and student affairs with focus on implementation and continued improvement of guided pathways.
- Program map A roadmap for student use that clearly explains how to complete a certificate and/or degree at Portland Community College. It is made up of two components:

- I. A sequenced set of courses required for completion.
- II. Any co-curricular milestones (advising checkpoints, internship/job-related experiences, or any other activities outside of required coursework) that are required or strongly encouraged for a student to be successful in their chosen program.
