AAT/AST Degree Updates – Anne Haberkern

State initiative driven by two legislations (HB 2998 IN 2017 AND SB 233 in 2021) mandates the creation of transfer pathways that guarantees "junior standing in the major" at all Oregon public universities. By Fall 2026, the college is required to implement two new degrees: Associate of Arts Transfer (AAT) and Associate of Science Transfer (AST). A MTM-CAP (Major transfer Map - Curriculum Articulation Policy) covers the requirements that are outlined for a given discipline.

Statewide faculty subcommittees design major-specific requirements, decide which degree(s) will be affected, and then recommend their plan s to the Transfer Council (which in turn recommends to the HECC). These are the MTMs that were approved by the HECC this month:

- Computer Science AST (must be implemented by Fall 2026 unless request for exemption)
- Biology AST (Fall 2027)
- Business AST (Fall 2027)
- English AAT (Fall 2027)
- Human Development and Family Services AAT and AST (Fall 2027)
- Sociology AAT and AST (Fall 2027)

DAC is the initial reviewer/recommender for Handbook polices that are degree-related and new AAT/AST majors. We will review/discuss handbook polices for AAT/AST at the May meeting and vote on AAT/AST handbook polices at the June meeting. After this, the AAT/AST handbook policies will continue through college workflow. SACs will review individual AAT/AST majors in Fall, and any recommendations will come through for DAC approval by January 2026 (for Fall 2026 implementation) or January 2027 (for Fall 2027 implementation).
