Hazardous Material Emergency Response Plan – Appendix C: Personal Protective Equipment

Personal protective equipment (PPE) used in clean-up operations is classified in four levels of protection.

- Level A provides the highest level of protection and includes a fully
 encapsulating chemical resistant suit, air supplied full face respirator, and
 chemical resistant gloves and boots.
- **Level B** includes a hooded chemical resistant suit, air supplied full face respirator, and chemical resistant gloves and boots.
- Level C includes a hooded chemical resistant suit, a half or full face air purifying respirator, and chemical resistant gloves and boots.
- Level D, which offers the lowest level of protection, includes clothing covering such as coveralls, safety glasses or splash resistant goggles, and chemical resistant gloves and boots.

The maximum level of protection provided by PCC is level C. Emergencies requiring higher levels of protection will be responded to by a third party, HAZMAT Team. The level of PPE required for a specific clean-up is determined by completing *Form 1: Spill Assessment* and *Form 2: Site Work Plan*.

The following tables identify the types of PPE available at each PCC Campus and which departments have been trained for their use. All respirators must be inspected monthly if it is intended for emergency use. The designated users must be trained in the equipment. For additional information on PPE and respirators, see *Chapter 12 – Personal Protective Equipment* and *Chapter 17 – Respirator Protection Program*.
