Clear Masks 	Can protect other people in the general public from the wearer's respiratory droplets. Face Shield 	Can protect other people in the general public from the wearer's respiratory droplets. <i>Face shields should not be used as a substitute for face coverings.</i>	No* , but can be a supplement to face coverings or masks	Only as a supplement to face coverings.	Any time an employee is working indoors. Any work outdoors when physical distance to another person is difficult to maintain.	Any work activities requiring a higher level of protection. May not be substituted in place of face coverings or medical-grade masks.	Employee/ PCC	All work areas and common use spaces
Medical-grade Mask 	Can protect other people from wearer's respiratory droplets. Can provide some protection to the wearer from other peoples' larger respiratory droplets.	Yes , for approved critical work tasks when staying apart is difficult to maintain.	No . There is a limited supply, and they should be conserved for required critical work tasks.	Approved critical work tasks requiring the employee to be closer than 6 ft to another person.	Any work activities requiring a higher level of respiratory protection. May not be substituted in place of an N/P95 or other type of respirator.	PCC	Custodial work Dining services Work tasks needing more than one employee to complete
KN, N, or P 95 Disposable Respirator 	Protects the wearer from inhalation of 95% of airborne particles.	Yes , for some specific non-COVID-19 hazards. In rare cases for COVID-19 protection.	Yes , under certain conditions**. Supplies may be limited, and they should be conserved for critical work tasks with specific respiratory hazards.	Any work tasks requiring an N or P 95 respirator as part of the normal work for trained, medically cleared and fit-tested employees. As a substitute for face coverings or masks in times of significant community transmission.**	Any work activities requiring a higher level of respiratory protection. May not be substituted when work task requires a half face or full-face respirator.	PCC	Pressure washing hazardous substances Sanding Grinding
