8	Hazard Communication	Active	Applies to departments that have chemical inventories and/or use chemicals; use office supplies, hand sanitizer, or cleaning compounds containing hazardous chemicals	As Needed	Yes

10	Control of Hazardous Energy - Lockout/Tagout	Active	Applies to departments that have equipment that is serviced, maintained, or repaired in which the unexpected energizing, start-up, or release of stored electrical, hydraulic, pneumatic, gravitational, potential, kinetic, thermal or chemical energy or radiation could cause injury. 12	Personal Protective Equipment	Active	Applies to departments that have exhausted all feasible engineering and administrative hazard controls and must rely on personal protective equipment (PPE) to protect employees		
13	Hazardous Building Materials	Active	Applies to departments that interact with building structures that contain hazardous building materials, such as asbestos, lead, radon, silica, etc.		
14	Powered Industrial Trucks, Material Handling Vehicles, and Powered Mobile Equipment	Active	Applies to departments that operate forklifts, powered pallet jacks, scissor lifts, powered mobile scaffolding, diesel or electric utility carts, floor or road maintenance vehicles, and earth moving equipment	Yes	Yes

16	Hot Work	Active	Applies to departments that have operations that generate heat, smoke or flames	As Needed

21	Regulated Waste	Active	Applies to departments that generate infectious waste, sharps, hazardous wastes (ignitable, corrosive, reactive or toxic wastes), used oil and petroleum products, fluorescent bulbs, ballasts, or batteries of any type		
22	Environmental Protection & Stewardship	Active	Applies to departments generating regulated wastes, recycling materials, storing materials in above ground or underground storage tanks and those departments where chemicals could flow to a drain or storm drain		
23	Cranes, Hoists, and Slings	Active	Applies to departments which operate cranes, hoists, lifts, wash racks and other equipment that elevates or conveys materials off the ground	Yes	Yes
24	Heat Illness Prevention Plan	Active	Applies to departments that have employees working in conditions in which the apparent temperature reaches 80 degrees F or higher	Yes	Yes
25	Wildfire Smoke Protection Plan	Active	Applies to departments that have employees working outdoors when the local air quality index (AQI) exceeds 35.5 ug/m <sup>3</sup> of smoke resulting from a wildfire	Yes	Yes
26	Scaffold Safety Plan	Active	Applies to departments erecting or using scaffolding at PCC (does not apply to operation of scissor Lifts)	As Needed	As Needed
27	Compressed Gas Safety Plan	Active	Applies to departments storing, transporting, or using compressed gases, including but not limited to propane, LPG, carbon dioxide, compressed air, breathing air, and refrigerants	As Needed	As Needed
