-STREAMLINED POLICIES: IN LINE WITH BEST PRACTICES, DETAILED PROCEDURES FOR CONFLICT OF INTEREST AND INDEMNIFICATION WERE REMOVED FROM THE BYLAWS. THESE WILL NOW BE MAINTAINED AS SEPARATE, BOARD-ADOPTED POLICIES, ALLOWING FOR MORE AGILE UPDATES.

AMENDED AND RESTATED BYLAWS

SECTION 1 PURPOSE

The Portland Community College Foundation, Inc. (the “Foundation”) is organized to promote student access to education, and to support vital educational opportunities for the community (the “Purpose”). In particular, the Foundation will fund scholarships and support educational programs to remove barriers to education. The Foundation’s Statement on Equity, Diversity, and Inclusion is fundamental to achieving the Purpose.

SECTION 2 BOARD OF TRUSTEES.

2.1 General Powers. The business and affairs of the Foundation shall be managed by a Board of Trustees (the “Board”) except as may be otherwise provided in these Bylaws, the Articles of Incorporation, or the Oregon Nonprofit Corporation Act (the “Act”).

2.2 Number of Trustees. The Board shall consist of not less than six nor more than 25 trustees. The specific number of trustees within that range shall be set by resolution of the Board. The number of trustees may be changed from time to time by amendment to these Bylaws or, within the above range, by resolution of the Board, but no decrease in the number of trustees shall shorten the term of any incumbent trustee.

2.3 Election and Terms.

(a) The trustees shall be elected by the Board. Trustees shall serve three-year terms, provided that the Board may elect a trustee to serve an initial term of less than three years so that not more than one plus one-third of the Board is up for reelection in any year. Trustees may serve two consecutive terms; provided, however, that if a trustee is serving as president in the final year of the trustee’s second term, then such trustee may be elected to serve for an additional term.

(b) Each Trustee’s term shall begin on July 1 immediately following the meeting at which such trustee was elected.

(c) Despite the expiration of a trustee’s term, the trustee may continue to serve until the trustee’s successor is elected, unless there is a decrease in the number of trustees.

(d) An employee or officer of Portland Community College (the “College”) is not eligible to be elected or to serve as a trustee, except as a non-voting ex-officio member of the Board.

2.4 Ex-officio Members of the Board. The following individuals are non-voting ex-officio members of the Board; (i) the president of the College; (ii) the Executive Director of the

Foundation, (iii) two members of the District's board (appointed by the District's board), and (iv) up to two students currently enrolled at the College (appointed by the Board). Unless the Board extends an invitation only voting trustees may attend an executive session of the Board meeting. The Board, in its sole discretion, may permit other individuals to attend Board meetings. However, the Board is not required to provide notice of Board meetings to any such individuals.

2.5 Meetings.

2.5.1 Regular Meetings; Annual Meeting. The Board shall meet at least two times each year. One of the regular Board meetings shall be designated as the annual meeting for the purpose of electing trustees and officers and transacting such business as may come before the meeting. The annual meeting shall be each year in the spring. By resolution and without other notice than such resolution, the Board may specify the time and place within the Portland Community College District (the "District") for holding regular meetings.

2.5.2 Special Meetings.

(a) **Power to Call.** Special meetings of the Board may be called by or at the request of the president, the executive committee, a majority of the Board, or any two trustees. The person or persons authorized to call special meetings may fix any place within the District as the place for holding any special Board meeting called by them.

(b) **Notice.** Notice of a special Board meeting shall be given to each trustee at the physical or electronic address shown on the records of the Foundation, as follows:

(i) The notice shall state the date, time, and place of, and agenda for, the meeting.

(ii) Notice by personal service shall be effective if delivered at the trustee's physical address at least two business days before the meeting.

(iii) Notice by electronic means shall be effective when sent if sent to the trustee's electronic address at least two business days before the meeting.

(iv) Notice by mail shall be effective if properly addressed and deposited in the official government mail at least five days before the meeting with postage prepaid.

2.6 Waiver of Notice.

2.6.1 Written Waiver. Whenever any notice to a trustee is required or permitted under these Bylaws, the Articles of Incorporation, or the Act, a written waiver of notice by the trustee that meets the requirements of this Section 2.6 shall be the equivalent of notice to the

trustee. The waiver shall specify the meeting for which notice is waived, be signed at any time by the trustee entitled to the notice, and be filed with the minutes or corporate records. Neither the business to be transacted at, nor the purpose of, any regular or special meeting of the Board need be specified in the waiver of notice of such meeting.

2.6.2 Waiver by Attendance. The attendance of a trustee at a Board meeting shall constitute a waiver of notice of such meeting unless the trustee, at the beginning of the meeting or promptly upon such trustee's arrival, objects to holding the meeting or transacting any business at the meeting, and does not vote for or assent to action taken at the meeting.

2.7 **Meetings by Telecommunications or Other Electronic Means.** Trustees may participate in a meeting of the Board by use of any means of communication by which (i) all persons participating may simultaneously hear each other during the meeting, or (ii) all communications during the meeting are immediately transmitted to each participating trustee and each participating trustee is able to immediately send messages to all other participating trustees. Participation by such means shall constitute presence in person at the meeting.

2.8 **Manner of Acting.**

2.8.1 Majority Action. The act of the majority of the trustees present at a Board meeting at which there is a quorum shall be the act of the Board unless the vote of a greater number is required by these Bylaws, the Articles of Incorporation, or the Act.

2.8.2 Presumption of Assent. A trustee, present at a Board meeting at which action on any corporate matter is taken, shall be presumed to assent to the action unless one or more of the following applies:

(a) The trustee's dissent is entered in the minutes of the meeting;

(b) The trustee delivers a written notice of dissent or abstention to the presiding officer of the meeting before adjournment; or

(c) The trustee forwards notice of dissent or abstention to the secretary of the Foundation immediately after the adjournment of the meeting.

2.8.3 No Withdrawal of Assent. A trustee who voted in favor of corporate action at a meeting, or is presumed to assent under Section 2.8.2, may not later dissent or abstain.

2.9 **Action Without Meeting: Vote by Email.** The board may, without a meeting, use email or other electronic means to take action required or permitted to be taken at a board meeting if:

(a) The Foundation has a record of an email address for each trustee;

(b) The Foundation sends to the email address of each trustee an announcement that the board will take action, a description of the matter on which the board will

take action, and a deadline of not less than 48 hours after the time the Foundation sends the announcement in which a trustee may vote; and

(c) The majority of trustees who hold office at the time vote in the affirmative, except to the extent that the Articles of Incorporation, these bylaws, or applicable law require the vote of a greater number of trustees.

A trustee may change their vote at any time before the deadline set forth in the email announcement. The board's action is effective on the deadline specified in the email announcement unless the announcement specifies a different effective date or time. The Foundation shall include the email announcement and a record of the trustees' votes in corporate records reflecting the action that the board took.

2.10 Action Without Meeting: Unanimous Written Consent. Any action required or permitted to be taken at a board meeting may be taken without a meeting if the action is taken unanimously by all trustees. The action must be evidenced by one or more written consents describing the action taken, signed by each trustee, and included in the minutes or filed with the corporate records reflecting the action taken. Action taken under this section is effective when the last trustee signs the consent unless the consent specifies an earlier or later effective date. For purposes of this section, an affirmative email sent by a trustee in response to a written consent is deemed to be a writing by the trustee. A unanimous written consent under this section has the effect of a meeting vote and may be described as a meeting vote in any document.

2.11 Quorum. One-half of the voting trustees in office shall constitute a quorum for the transaction of business at any Board meeting. If less than one-half of the trustees are present at a meeting, a majority of the trustees present may adjourn the meeting without further notice.

2.12 Minutes. The Board shall keep minutes of its meetings and shall cause them to be recorded in books kept for that purpose.

2.13 Resignation. Any trustee may resign at any time by delivering written notice to the president. Such resignation shall take effect at the time specified in the notice or, if no time is specified, upon delivery. Unless otherwise specified in the resignation, the acceptance of such resignation shall not be necessary to make it effective.

2.14 Removal. A trustee may be removed, with cause, at a meeting of the Board called expressly for that purpose, by vote of the majority of trustees in office. A trustee may be removed by a vote of the majority of trustees in office if the trustee misses more than two consecutive unexcused meetings. Any vacancy on the Board shall be filled by a favorable vote of the majority of the remaining trustees. A trustee elected to fill a vacancy shall be elected for the unexpired term of such trustee's predecessor in office.

2.15 Standing Committees. The Board may create one or more committees of the Board and appoint members of the board to serve on them or designate the method of selecting committee members. Each committee shall consist of two or more trustees who serve at the

pleasure of the Board. Standing Committees of the Board may, to the extent specified by the Board, exercise the authority of the Board; provided, however, that no committee may:

(a) Authorize distributions, provided that this restriction does not apply to payment of value for property received or services performed or payment of benefits in furtherance of the Foundation's purposes;

(b) Approve or recommend dissolution, merger, or the sale, pledge, or transfer of all or substantially all of the Foundation's assets;

(c) Elect, appoint, or remove trustees or fill vacancies on the board or on any of its committees; or

(d) Adopt, amend, or repeal the Articles of Incorporation or Bylaws.

2.16 Advisory Committees. The Board may create one or more other committees and appoint members of the board to serve on them or designate the method of selecting committee members. Members of these committees need not be members of the Board, but at least two trustees shall serve on each such committee. These committees shall have no power to act on behalf of, or to exercise the authority of, the Board, but may make recommendations to the Board.

2.17 Committee Administration. Except as provided in Section 2.18, the provisions of these bylaws governing meetings, action without meetings, notice and waiver of notice, and quorum and voting requirements of the Board shall apply to committees and their members. Each committee shall also report on its activities at the regular meetings of the Board. The president of the Board shall serve as an ex-officio member of all committees.

2.18 Executive Committee. The Executive Committee shall consist of the president, vice-president, treasurer, secretary, and the chairs of each of the Strategic Planning, Engagement and Outreach, and Investment Committees. The Board may, at its discretion, nominate and approve an additional trustee to serve on the Executive Committee. The Executive Director shall serve as an ex-officio non-voting member. The Executive Committee shall meet as determined by the president or at the request of the majority of the trustees then constituting the Executive Committee. A quorum of the Executive Committee shall be constituted when a majority of the Executive Committee is in attendance, at least one of whom is the president or the vice-president. Subject to the limitations set forth in Sections 2.15(a)-2.15(d) above, the Executive Committee may exercise all of the powers and duties of the Board during the interim between Board meetings. All actions of the Executive Committee shall be promptly reported to all trustees at the next meeting of the Board.

SECTION 3 OFFICERS.

3.1 Officers. The officers of the Foundation shall be a president, vice-president, treasurer, secretary, Executive Director, and such other officers as the Board may from time to time determine, each of whom shall be elected by the Board from the trustees except for the

Executive Director who shall serve in an officer role by virtue of their employment. The position of secretary and treasurer may be filled by the same trustee. Each officer shall have the powers and duties customarily incident to the office, subject to the direction and control of the Board. The president of the Foundation shall be elected by the Board at the annual meeting and shall serve for a term of two years. The remaining officers of the Foundation shall be elected by the Board at the annual meeting and shall serve for a term of one year or, if later, until successors are elected and take office. Election of other officers may take place at regular or special meetings where notice of the meeting has specified the election for such offices is to be held at that meeting.

3.2 Resignation. Any officer may resign at any time by written notice to the president or, in the case of the president's resignation, by written notice to the secretary. A resignation shall take effect at the time it specifies or, if the time is not specified, upon delivery. Unless otherwise specified in the resignation, acceptance shall not be necessary to make it effective.

3.3 Removal. Any officer or agent elected or appointed by the Board may be removed by the Board, with or without cause. Such removal shall be without prejudice to the contract rights, if any, of the person so removed. Appointment or election as an officer or agent of the Foundation shall not in itself create any contract rights.

3.4 Vacancies. A vacancy in any office because of death, resignation, removal, disqualification, creation of a new office, or any other cause may be filled by the Board for the unexpired portion of the term.

3.5 Compensation. Officers shall not receive any compensation for personal services as officers. Such officers may, if authorized by Board resolution, be reimbursed for their actual expenses, if any, incurred in performance of their duties.

SECTION 4 OFFICES.

4.1 Principal Office. The principal office of the Foundation shall be located at the principal place of business, or such other place within the District as the Board may designate. The Foundation may have such other offices, either within or outside the state of Oregon, as the Board may designate or as the business of the Foundation may require.

4.2 Registered Office. The registered office of the Foundation shall be located within the state of Oregon and may be, but need not be, identical with the principal office.

SECTION 5 CONFLICTS OF INTEREST.

5.1 Trustee Conflict of Interest. A conflict of interest transaction is a transaction with the Foundation in which a trustee of the Foundation has a direct or indirect interest, as defined in ORS 65.361. The board shall adopt a policy that (a) requires trustees and officers to disclose any interest that constitutes or could result in a conflict of interest and (b) sets out procedures for reviewing and resolving such matters in accordance with law.

SECTION 6 ANNUAL AUDIT.

6.1 **Annual Audit.** The president of the Foundation shall have an annual audit or review performed of the accounts of the Foundation, effective as of the end of the Foundation's fiscal year.

SECTION 7 INDEMNIFICATION AND INSURANCE.

7.1 **Indemnification and Insurance.** The Foundation shall indemnify to the fullest extent of the law its trustees, officers, employees, or agents as set forth in the Foundation's Articles of Incorporation. The Foundation may purchase and maintain insurance on behalf of an individual against liability asserted against or incurred by the individual who is or was a trustee, officer, employee, or agent of the Foundation, or who, while a trustee, officer, employee, or agent of the Foundation, is or was serving at the request of the Foundation as a trustee, officer, partner, director, employee, or agent of another foreign or domestic business or nonprofit corporation, partnership, joint venture, trust, employee benefit plan, or other enterprise; provided, however, that the Foundation may not purchase or maintain such insurance to indemnify any trustee, officer, or agent of the Foundation in connection with any proceeding charging improper personal benefit to the trustee, officer, or agent in which the trustee, officer, or agent was adjudged liable on the basis that personal benefit was improperly received by the trustee, officer, or agent.

7.2 **Survival of Rights.** The rights conferred on any person by this Bylaw shall continue as to a person who has ceased to be a trustee, officer, employee, or other agent and, if such person is deceased, shall insure to the benefit of such person's heirs, executors, and administrators.

7.3 **Savings Clause.** If all or any part of this Bylaw shall be invalidated on any ground by any court of competent jurisdiction, the Foundation shall indemnify each trustee, officer, or other agent to the fullest extent permitted by any Bylaw or part of a Bylaw not invalidated, or by any applicable law.

SECTION 8 AMENDMENTS.

These Bylaws may be amended only by a majority vote of the trustees in office at the time the amendment is adopted; provided that (a) any proposed amendment shall be provided to the president of the College at least 30 days prior to the Board meeting at which the amendment is approved, and (b) no amendment shall be adopted that the College president determines conflicts with Article III(a) or Article V(a) of the Articles of Incorporation, Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (or successor provision of the Code or any future federal tax code), or the Act, provided the College president provides notice to the Board of such determination and the basis therefor within 30 days of notice to the College president of the proposed amendment. Subject to compliance with the immediate preceding sentence, an amendment may be adopted at any regular or special meeting of the Board; provided that the notice of the meeting shall state that the purpose, or one of the purposes, of the meeting is to

consider a proposed amendment to the Bylaws and (i) contain or be accompanied by a copy or summary of the amendment, or (ii) state the general nature of the amendment.
