

INTERNATIONAL STUDENT HEALTH INSURANCE AGREEMENT

Please read all parts of this document carefully, sign, and submit all supporting documentation as needed.

PCC INTERNATIONAL HEALTH INSURANCE REQUIREMENT

It is mandatory for all F-1 and J-1 students as well as all J-2 dependents with I-20s or DS-2019s from PCC to be covered by the international student health insurance from Pacific Source. It is your responsibility to log in to Pacific Source's payment portal to pay for your health insurance premium each term.

- J-2 dependents of J-1 students are required to have mandatory health insurance coverage through Pacific Source.
- F-2 dependents of F-1 students are not required to have mandatory health insurance coverage through Pacific Source, but it is highly recommended.

HEALTH INSURANCE COVERAGE INFORMATION

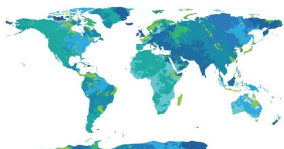
International student health insurance coverage will begin according to the dates listed on the PCC website for the term.

- Pacific Source is PCC's mandatory international student health insurance provider
- Your health insurance premium cost is \$360.00 per term (each dependent is an additional \$360.00 per policy).
- You must make your quarterly payments directly to Pacific Source through their member portal.
- You are required to pay for insurance during:
 - Fall, Winter, Spring, and Summer terms,
 - vacation terms,
 - OPT, and
 - reduced course load terms.

EXCEPTION FOR GOVERNMENT-SPONSORED STUDENTS

The only exception to the health insurance requirement are government-sponsored students and their dependents with health insurance itemized in their Financial Guarantees (Eg. SACM, Embassy of Kuwait, Qatar NAPT)

- All accepted government-sponsored students must submit a copy of their Financial Guarantee, award letter or billing authorization to oie.insurance@pcc.edu before the first day of classes of their first term at PCC in order to receive an exception from this requirement.
