TIMELY WARNING CRIME ALERT – MOTOR VEHICLE THEFTS AND THEFT FROM VEHICLE

The Department of Public Safety is providing this warning to the PCC community to aid in the prevention of similar crimes by alerting the community about the incident and to provide information which allows individuals to make informed decisions about their personal safety.

DPS issues Timely Warnings - Crime Alerts to the campus community when a criminal incident occurs within PCC's Clery geography and represents a serious or continuing threat to the safety of students, employees and others.

INCIDENT 1

DATE & TIME: On Wednesday 1/19/22 at approximately 12:26 p.m. DPS received a report that a blue 2000 Dodge Ram truck with the license plate XGH179, belonging to an employee parked in the Grounds parking was stolen.

LOCATION: Sylvania campus

SUSPECT DESCRIPTION (*provided by reporting party*): There is no suspect description at this time.

INCIDENT 2

DATE & TIME: On Monday 1/24/22 at approximately 10:19 a.m., DPS received a report that a white 1997 Honda Civic vehicle with the license plate VLZ587 was stolen from the parking lot near the Sylvania College Services Building.

INCIDENT 3

DATE & TIME: On Friday 1/21/22 at approximately 8:50 a.m. DPS received a report from a staff member that their vehicle window was smashed and items were taken from the interior of the vehicle while it was parked in the parking lot near the Sylvania College Services Building.

DESCRIPTION OF MOTOR VEHICLE DAMAGED: Blue Ford Ranger.

SUSPECT DESCRIPTION (*provided by reporting party*): There is no suspect description at this time.

PCC's Department of Public Safety Recommendations – Motor Vehicle Theft

- ⑩ **If you observe a crime in progress or discover your vehicle has been stolen, go to a safe location immediately, call 9-1-1 if you are off campus or DPS emergency at 971-722-4444 if you are on a PCC campus.**
- ⑩ **Do not attempt to apprehend any suspects or perpetrators of crime.** Your personal safety and the safety of others around you should be your primary concern.
- ⑩ **Lock your car and do not leave valuable inside it.**
- ⑩ **Be a good witness:** It is important to recall what you observed and provide as many details as possible to law enforcement such as: the sex, race, age, height, hair color, clothing, tattoos, scars of any suspects and a description of the make and model of any vehicle used in the crime and its license plate if possible.
- **Blue light emergency phones** are direct lines to the PCC Public Safety Department. With one push of a button, you'll be connected to help.
