- Be a perceptive witness: If you are the victim of a crime or see a crime in progress, take a deep breath and try to observe as many details as possible to report to law enforcement such as your location, and a description of your perception of the suspect's gender, race, age, height, hair color, clothing worn, tattoos or scars. If a vehicle is involved take note of the color, make and model and its license plate if possible.
