

**ARTICULATION AGREEMENT**  
**Between**  
**GRAND CANYON UNIVERSITY**  
**And**  
**PORTLAND COMMUNITY COLLEGE**

**1. Purpose**

The purpose of this articulation agreement between Grand Canyon University and Portland Community College is to facilitate our students' progress toward their educational and career goals by simplifying the transfer of academic credits between the two institutions. This document establishes transfer criteria for undergraduate credit courses earned at Portland Community College to be utilized toward earning a degree at Grand Canyon University.

**2. The Articulation Agreement**

Portland Community College and Grand Canyon University each formally recognize the professional integrity and academic stature of the other. Both institutions view the other as active educational collaborators, committed to providing greater educational opportunities and services for students transferring between institutions. Each institution, furthermore, is dedicated to serving students from all walks of life, regardless of race, ethnicity, religion, sex, disability, color, age, marital status, national origin or other non-merit factors.

This commitment supports strongly the concept of seamless transfer that embraces the principle that transfer students should not be required to repeat competencies already achieved. Residency and other applicable requirements remain in effect for each institution as published in its respective College Catalog.

**3. Equivalent Courses**

Grand Canyon University currently recognizes the courses listed on Exhibit A of this document as equivalent and will accept them for equivalent general education, major courses, prerequisites or electives as indicated. Exhibit A may be changed from time to time due to accreditation and regulatory requirements, program changes, etc. Grand Canyon University will give notice as far in advance as reasonably possible of any changes so that Portland Community College students may adjust their courses of study as necessary. Students participating in the program must have the required Grade Point Average (GPA) for the desired program at the time of their transfer (e.g., currently, a GPA of "C-" or better for the BS; a GPA of "B" or better for the MBA), and otherwise meet all criteria for admissions and other applicable requirements under Grand Canyon University's policies and procedures that it may change from time to time under its sole discretion.

**4. Longevity of the Agreement**

This articulation agreement between Portland Community College and Grand Canyon University will remain in force until it is discontinued by either educational partner with written and reasonable notification to the other university prior to the identified cancellation date in order to protect all students transferring between these institutions.

## 5. Disputes Under the Terms of the Agreement

Any disputes arising under this agreement will be resolved by the institution to which credits are being transferred.

## 6. Promotion


Each institution may refer to this agreement in its respective literature, including websites, provided that it does not violate the business standards or other policy or requirements of an accrediting or regulatory body.


## 7. Commitment
