### **REVISION: AAS-CJA: Criminal Justice AAS Degree**

- CJA 230 is being revised reducing credits from 4 to 3 which reduces the degree credit total from 91 to 90. However, CJA 230 has not been recommended for approval by the Curriculum Committee yet since it was postponed till January's meeting.
- Removed WR 227 from degree coursework and replaced it with COMM 214; the program will track its progress for a year to see if it better meets student learning outcomes (note prerequisites for CJA 230 changed by removing WR 227 and replacing it with WR 121 or equivalent)
- Added Professional Competence to Core Outcomes

# INACTIVATE: ACERTP-CORT: Corrections Technician Less Than One-Year Career Pathway

- Career Pathway Certificate has been inactivated due to continuous low enrollment and low demand in job market
- 3 students are still enrolled in the certificate program and will be allowed to complete necessary courses; Curriculum Office will communicate with program advisors on how this will work based on the catalog year of admission

### **REVISION: AAS-NURS: Nursing AAS Degree**

• Degree outcomes have been revised and clarified to more closely correspond with the language of Oregon Consortium for Nursing Education (OCNE) and its professional standards

### ACERTP-IF: Interior Furnishings Less Than One-Year Career Pathway

- Credit requirement for ACERTP-IF has been reduced from 41 to 38 due to the removal of ART 215

# A106-ASSOCIATE DEGREES: Comprehensive Requirements – Update On Approval Process

- **A 102 AAS General Education Credit Requirement**: Anne Haberkern, update on implementation groups review and next steps
  - The general education requirements for AAS Degrees are currently stated as a minimum of 16 credits. This leads to confusion among students who often transfer in 3 credit Gen Ed course and having completed four courses of Gen Ed believe they have met the degree requirements only to find out just before graduation that they are a credit or two shy and therefore must take an additional 3 to 4 credit Gen Ed course.
  - A CTE-supported proposal is to restate the Gen Ed requirement in terms of courses (i.e. 4 courses).
  - This proposed change would reduce the minimum number of general education credits from 16 to 12 – and since the credit total for degrees is based on the minimum number of credits required to meet the requirements this would also lower the credit total for the degrees.
  - About 1/3 of AAS degrees have a credit totals of 90-93 and the proposed change would put these degrees below the 90 credit minimum for AAS degrees requiring them to add additional credits to meet the minimum credit requirement. In order to give these degrees sufficient time to add additional credits the implementation group has suggested that the DAC move forward with approving the change to A102 this year but not publish the change in the catalog until Fall of 2020 giving the impacted degrees time to add credits. Any student who would be adversely impacted by this delayed implementation during the 2019/2020 academic year would be able to use the 4 course standard to meet the Gen Ed requirement.
