A107-Associate Degree Requirements - General Education: Eriks Puris

- The new Gen Ed approval process is currently being developed by GEARS and everyone will have to look at the Gen Ed Philosophy statement.
- Ann Cary provided a brief review of the current gen ed approval process as well as the new process proposed to begin next year; in both processes, the philosophy statement is part of it.
 - The philosophy statement has been around for a long time, but has not been updated for at least 26 years.
 - Given the current revision of the gen ed approval process and other projects at the college, there is simply not enough time to do a full review and update it now prior to next year's GEARS process, as that would be a college-wide endeavor.
- The use of "citizens" and "citizenship" in the philosophy statement is particularly problematic given PCC's status as a sanctuary college.
 - Given that all SACs will be looking at the philosophy statement in the coming months in preparation for GEARS, it is important to revise this particular element.

• The committee approves the changes to the Gen Ed Philosophy Statement.

A102-Associate Degree Requirements – Associate of Applied Science Degree (AAS): Eriks Puris

- The DAC has already discussed the initial changes; however, APS is considering additional changes and is first in the workflow.
- The DAC can vote on the changes in the May meeting, the changes will go before the EAC later in May and can be voted on in June, so any changes to A102 can still go through this year.
- The DAC decides to vote next month.

DISCUSSION ITEMS:

A106-Degree Residency Requirements

- Does the current requirement meet the evolving enrollment needs of our students? Is 30 credits the right number (See A106 for current policy).
 - A straw poll was conducted regarding the number of credits required for degree residency and the results were emailed to the committee members.
 - o Of the 15 voting members, 12 cast a vote:
 - 50 credits: 1 member,
 - 30 credits: 1 member,
 - 24 credits: 10 members.
- More discussion to follow at next month's meeting.
