- Added EET 256A and EET 256B courses
- Removed EET 254, EET 256 courses
- Went from 94 credits to 97 total credits for degree

ACERT1-EET: Electronic Engineering One-Year Certificate

- Implementation term: Fall 2018
- Split EET 101 into 2 courses- EET 101A (introductory) & EET 101B (advanced). Both are a 1 credit course
- Added course options for the writing and math requirement so that it is easier for students to meet the related instruction requirement.
- Went from 54 credits to 55 total credits for degree

- Split EET 101 into 2 courses- EET 101A (introductory) & EET 101B (advanced). Both are a 1 credit course
