# **AAS-EXS: Exercise Science AAS Degree**

- Added HUS 101 Mental First Aid (1 credit) and reduced electives from 14 to 13 credits.
- Existing course FT 102 Injury Prevention & Management (3 credits) has been split into FT 100 Emergency Response for Fitness Professionals (1 credit) and FT 110 Injury Prevention & Management (2 credits). For degree replace FT 102 with FT 100 and FT 110.
- Degree credit total remains at 90 credits

• In order to propagate name change of degree wording in Outcome 2 changed: Apply the knowledge and skills gained in a Fitness Science an Exercise Science AAS Degree when critically evaluating and interpreting fitness and wellness information.

## ACERTP-FPT: Personal Trainer Less Than One-Year Career Pathway Certificate

- Added HUS 101 Mental First Aid (1 credit).
- Existing course FT 102 Injury Prevention & Management (3 credits) has been split into FT 100 Emergency Response for Fitness Professionals (1 credit) and FT 110 Injury Prevention & Management (2 credits). For degree replace FT 102 with FT 100 and FT 110.
- Certificate credit total increases from 40 to 41 credits.

# ACERTP-GFL: Group Fitness Leader Less Than One-Year Career Pathway Certificate

- Added HUS 101 Mental First Aid (1 credit).
- Existing course FT 102 Injury Prevention & Management (3 credits) has been split into FT 100 Emergency Response for Fitness Professionals (1 credit) and FT 110 Injury Prevention & Management (2 credits). For degree replace FT 102 with FT 100 and FT 110.
- Certificate credit total increases from 30 to 31 credits.

# ACERTP-HOA: Healthy Older Adult Fitness Less Than One-Year Career Pathway Certificate

- Added HUS 101 Mental First Aid (1 credit), FT 100 Emergency Response for Fitness Professionals (1 credit) and FT 110 Injury Prevention & Management (2 credits).
- Certificate credit total increases from 26 to 30 credits.

#### **AAS-PARA: Paralegal AAS Degree**

- Change from Open Enrollment to Restricted Enrollment. Program wants students to meet with advisors before entering program.
- Revised restricted General Education course list to reflect courses removed from Gen Ed list. Gen Ed course list is restricted to meet accreditation standards.

### ACERT1-MSD: Management/Supervisory Development One-Year Certificate

- Removed MSD 111 Workplace Correspondence (3 credit) and replaced it with WR 227
  Technical and Professional Writing 1 (4 credit) or BA 205 Business Communication Using
  Technology (4 credit)
- Removed MSD 216 Budgeting for Managers (3 credit) and replaced is with BA 218 Personal Finance (4 credit)
- Changed WR 121 English Composition to WR 121 (or any curse for which WR 121 is a prerequisite)

- Certificate credit total increases from 45 to 47
- Revised outcomes to match revised program outcomes.

# ACERTP-THAS: Therapeutic Horticulture Activity Specialist Less Than One-Year Career Pathway Certificate

- To meet accreditation requirement GRN 267 Introduction to Professional Therapeutic Horticulture increased from 2 credit to 3 credits.
- Certificate credit total increases from 38 to 39
- Changed implementation to Fall 2018

# ACERTP-CCI: Creative Coding and Immersive Technologies Less Than One-Year Career Pathway Certificate

• New short-term certificate of 24 credits meets new industry standard competencies required to create interactive and immersive experiences for diverse audiences.

# ACERTP-MMC: Multimedia Less Than One-Year Career Pathway Certificate

- New short-term certificate of 20 credits meets employer demand for multimedia specialists and production assistants.
