C100: Certificates:

Because the DAC recommended that a limit be imposed on the number of credits of independent study that can be used to meet degree requirements the committee discussed whether a similar limit should be imposed on certificates. Due to the limited to non-existent role that independent study credits play in certificates the committee decided that at this time there is no need to create policy to limit the number of independent study credits that can be used to meet certificate requirements.

DISCUSSION ITEMS:

General Education:

Eriks attempted to summarize the proposed General Education Framework in a two minute elevator pitch, after which the committee reviewed current progress on this topic to better anticipate its role in the process of reevaluating general education courses beginning fall 2019.

Organizational Restructuring:

Cheryl Scott gave a brief update on the ongoing organizational changes, of note to the DAC: Workforce & Community Development (Assoc. VP Marc Goldberg) is being moved from Executive Vice President Sylvia Kelley's portfolio to Academic Affairs under Vise President Katy Ho. Greater integration between non-credit and credit programs is anticipated in the future.
