## **Focus Award Guidelines**

Discussion: Kendra handed out an outline of the latest revisions for the committee members to review. Transferability – intention is that there should alignment with a major at one or more institutions, but alignment can be broad. Discussion around the statement that courses should be available "at all four campuses or online – what was the intent?" Agreement that the statement was intended to convey broad availability to complete the focus award for students at the various campuses, but difficult to state in a way that doesn't seem proscriptive – every course doesn't have to be offered at every campus. Also, it may be that some awards will be developed that are more specialized and have a majority of courses, or a specific course, that is only offered at one campus. Removal of this statement approved. New guidelines unanimously approved to be included in the 13/14 catalog. Susanne will share at the June EAC.

AAS Math Competency: postponed until Retreat

Sustainable Agriculture: Betsy Julian, Michael Meagher, and Alissa Leavitt

Discussion: Betsy, Michael and Alissa provided informational background on this area of exploration for potential new PCC degrees and/or certificates. There is a large group of interested PCC members and local farmers that are assessing the needs/demand for a Sustainable Agriculture Program. Farming

courses could take place at Rock Creek but other courses could be taken at other campuses. They are exploring articulation agreement with OSU and other schools with agricultural programs. Preliminary research indicates possible careers in: food distribution specialist, urban farmer, etc. Will keep committee informed as research continues.

## 3:45 NEW: Lactation Consultant Certificate: Alissa Leavitt

Discussion: This new academic program is a collaborative effort between the current CEU program and Health SAC to develop a credit Lactation Consultant Certificate. As such, students may use financial aid, meet national certification requirements, and acquire course work that transfers. If approved, the Health SAC will initially host this new program. Program offers two certificates, essentially two "tracks". Health professionals (national certification list of professions that qualify) can have pre-requisites waived, get credit for previous clinical experience, and enter directly into 13 credit cert. Those who do not have clinical experience take 28 credits of pre-requisites (or can have waived on basis of profession) and complete the 27 credit cert which includes clinical hours. Discussion on course equivalencies for pre-requisites and how to best state this in the catalog occurred. Curriculum office staff will work with SAC. The goal is that students can complete the course work in spring 2014 for the 13 credit option and sit for the national boards. Our ability to offer courses in winter and spring will be partially determined by internal and external approval process timing. Curriculum Office and SAC will work on this together. Dave moved. Kathleen seconded. Unanimous recommendation for approval. APPROVED.
