We Are Here to Respect, Protect and Support

PCC's goal is to provide an atmosphere that encourages people to realize their full potential.

All members of our community, including our guests and visitors, deserve to learn and work in a fair and safe environment—and we take our responsibility to provide this space seriously.

PCC is charged with investigating all reported misconduct and gender-equity concerns; offering support to the people involved; and implementing measures to maximize safety. When we respect, protect and support one another, our community thrives.

If you have experienced sexual harassment, sexual assault, domestic or dating violence—or any other behavior that has made you feel unsafe or unwelcome—we are here to help.

What is Sexual Misconduct?

SEXUAL ASSAULT

Any actual or attempted sexual contact made without a person's consent.

STALKING

A course of conduct directed at a specific person that would cause a reasonable person to fear for their or others' safety, or to suffer substantial emotional distress.

DATING VIOLENCE

Includes violence by a person who has been in a romantic or intimate relationship with the victim. Whether there was such a relationship will be gauged by its length, type, and frequency of interaction.

DOMESTIC VIOLENCE

Includes asserted violent misdemeanor and felony offenses committed by the victim's current or former spouse, current or former cohabitant, person similarly situated under domestic or family violence law or anyone else protected under domestic or family violence law.

RETALIATION

Retaliation means any adverse treatment that is taken because a person engaged in protected activity (e.g., opposing discriminatory practices, filing a complaint, or participating in an investigation).

SEXUAL HARASSMENT

Unwelcome sexual conduct that creates a hostile, intimidating, or unsafe environment.

CONSENT

Consent is a knowing, voluntary and mutual agreement to engage in sexual activity. Consent can be withdrawn at any time.

Know Your Rights

- You have the right to learn and work in a safe environment. PCC follows a zero tolerance policy for all forms of sexual misconduct and gender-based discrimination.
- You have the right to a prompt and fair investigation. PCC is required to investigate all reports of sexual misconduct within 60 college work days.
- You have the right to file a complaint without fear of retaliation. Complainant or witnesses who report sexual misconduct are protected from retaliation under the law.
- You have the right to access support and health services. PCC offers confidential counseling services and can connect you with on- and off-campus resources to help you heal.
