



#### Academic Policies and Standards (APS)

- Revising policy C102: Credit for Prior Learning
- Revising policy G301: Grading Guidelines
- Revising policy S701: Syllabus Standards (result of student request for "sanctuary college" statement on syllabus)
- Creating a new Transfer Credit policy
- Formed Instructional Use of Social Media workgroup: developing guidelines for best practices and recommending revisions to relevant college policies

### Degrees and Certificates (DAC)

- Ensures the value, viability, and vitality of PCC degrees and certificates
  - Value to employers and transfer institutions
  - Viability to students by creating tractable credential paths
  - Vitality to faculty who continuously evolve PCC credentials to meet the changing needs of the workplace and transfer institutions.

Advancement of Educators Committee (AEC)

Collaborate with the administration to improve policies and procedures to encourage equity, access, and participation for all educators

Encourage discussion to address and resolve current inequities for contingent faculty at PCC

Foster transformative institutional change based on empirical evidence and appreciation for the important role of educators in student learning and success

### Academic Integrity Task Force Recommendation

PCC should establish a single point of responsibility for Academic Integrity, whether an Office of Academic Integrity or another centralized entity

#### Four Priorities:

- PCC should formalize the academic integrity violation process into an online form similar to the students of concern form.
- PCC should add options for educational responses to academic integrity violations
- PCC should provide professional development opportunities for faculty and educational opportunities for students related to academic integrity
- PCC should evaluate and pilot plagiarism detection software
