REPORT:

With passage of the bond measure, the College has the need to contract with a qualified firm to provide Comprehensive Programming Expansion and Renovation (Architectural) Services for the Sylvania Campus. Services are to include coordination with the City of Portland regarding the existing Master Plan and amendments, if necessary, plus full professional architectural services related to all other phases of the program.

A Request for Proposals (RFP) for these services was issued and advertised* on November 29, 2000. Copies of the RFP documents were sent to forty (40) firms. A total of ten (10) proposals were received in response to the RFP. Proposals were reviewed and rated by the committee members based on the following criteria: team qualifications, land use coordination with the City of Portland, team structure and flexibility, skills at controlling project costs, availability to provide resources for the duration of the project, partnering processes, proposed work plan, ability to meet deadlines, fee methods and establishment, work coordination and change order history, communication products, integration of interior design and furniture selection, CM/GC experience, and educational specific experience.
