ADOPT NEW BOUNDARIES FOR BOARD ZONES

REPORT:

The board is required by ORS 341.175 to redraw board zone boundaries following each federal census to align zone boundaries to be 'as nearly equal as feasible' in size of population. The board has discussed this issue at several meetings and determined that the following boundaries, which are within 3 percent of the 'equal' population size of 138,967, meet the statutory requirements.

Summary of Changes:

Zone 1: City of Lake Oswego in Clackamas County. Portions of Washington County bordered on the north by Scholls Ferry Road, and including Tualatin, Sherwood and Durham.

Zone 2: North Portland and St. Johns in Multnomah County, from Willamette River at I-84 north following 19th, 17th and 15th to Prescott and east to 57th and Cully to Sandy Blvd on south. North from St Johns to include St. Helens and portions of Columbia County.

Zone 3: East Portland from east border of college south from Sandy Blvd to Clackamas County line and west to 47th, 44th and 49th to Division, west on Division to 26th, south to Holgate and bordering Oaks Park Rd on west. Includes a small portion of Clackamas County in Sellwood.

Zone 4: North Portland north of I-84 bounded on North by Prescott on east by Cully and 57th on west by 15th, 17th and 19th. South of I-84 bounded on east

by 51st, 47th, 44th and 49th, to Division and west to 26th and south to Holgate. On west side of Willamette all of downtown Portland south to Palatine Hill Rd, bordered on the west by Barbur. West from downtown along Patton to Washington County line, into Washington County to 113th and north along the Washington County border into Columbia County and the city of Scappoose.

Zone 5: Multnomah County from Patton Rd. south to Clackamas Co border, west to 217 in Washington County. West from 217 at Rt. 8 to 185th. North on 185th to Hwy 26, east to 153rd and north to Springville. South at Washington Co. border along Saltzman and 113th.

Zone 6: Washington County from Tualatin Valley Hwy south to Tualatin-Sherwood on the east and south into Yamhill Co, taking in Newberg and Bald Peak. Bordered on West by River Road and Dixon Mill. Includes a portion of Washington County north of TV Hwy bordered by Hwy 26, to north, 185th to east and Cornelius Pass to west.

Zone 7. Washington County from Cornelius Pass and River Road on east to county line on West. North into Vernonia to Columbia County border on north and Pisgah Lookout Road on east.

RECOMMENDATION: That the board resolves to adopt these changes and directs staff to provide the census block information to the elections authorities.

Director Anderson moved to approve Resolutions 02-066 through 02-073 by consent agenda and it passed unanimously.
